

HIGHLIGHTS: JANUARY-SEPTEMBER 2025

The value of goods exported from the state through September 2025 amounted to \$20,623,042,089, a decrease of \$619.5 million, or 2.9%, vs. 2024. Total U.S. exports increased by 4.5% during the same period. Wisconsin currently ranks No. 21 among the 50 states in the value of goods exported through September 2025, the same position held after the third quarter of 2024.


- **Exports by product category.** Exports of industrial machinery set a new monthly high in March 2025, pushing the total through September to \$6.5 billion, an increase of \$625 million, or 10.6%, from 2024. Coming off a record high for the whole of 2024, electrical machinery exports decreased by \$335.4 million, or 13.7%, through September 2025. Exports of vehicles and parts continued its decline through the third quarter of 2025, down \$393.2 million, or 27.4%, after declining 7.6% for the whole of 2024. Of the top 20 product categories, exports of miscellaneous manufactured articles grew by the largest percentage value, up \$119.5 million, or 139.3%, with sanitary pads, brooms, and pencils seeing the largest growth.
- **Exports by market.** Canada and Mexico continue as Wisconsin's top two export destinations through September 2025, collectively representing 42.4% of the state's total exports, although decreases to both markets were recorded in the amounts of \$753.5 million (11.8%) and \$205.8 million (6.2%), respectively. Significant increases were realized in exports to the Netherlands (up \$312.7 million, or 53.7%), Japan (up \$115.2 million, or 24.1%), and Singapore (up \$214.8 million, or 62.1%).
- **Imports.** Wisconsin's imports decreased, down \$1.26 billion, or (4.27%), totaling \$28,135,007,743 through September 2025 compared to 2024. The top category, industrial machinery, grew by \$224.4 million, or 3.61%, followed by electrical machinery, which grew by \$321.3 million, or 8.99%. Total imports from Canada reached \$4.3 billion (a decrease of \$401.6 million, or 8.5%), followed by China, which supplied \$4.2 billion of Wisconsin's imports.

COUNTRY SUMMARY

- **Canada** continues as Wisconsin's top trading partner, reflecting highly integrated economies and supply chains. While trade with Canada decreased slightly in 2024 (down \$277.2 million, or 1.9%), the total value of trade between Wisconsin and Canada decreased at an accelerated pace through September 2025, down \$753 million, or 11.82%. Wisconsin maintained a trade surplus with Canada in the amount of \$1.305 billion.
 - Exports of six of the top 10 product categories decreased through the third quarter of 2025, including industrial machinery (down \$263.2 million, or 17.8%) and vehicles and parts (down \$153.3 million, or 28.6%). Increases occurred in shipments of miscellaneous manufactured articles (up \$121.4 million, or 186.6%) and beverages, spirits, and vinegar (up \$25.9 million, or 18%).
 - Seven of the top 10 product categories imported from Canada recorded decreases, including plastic products (down \$52.1 million, or 11.3%), mineral fuel/oil (down \$165.7 million, or 36.5%), and paper products (down \$52.7 million, or 12.5%). Increases were seen in special classification provisions and wood pulp, which increased by \$29.3 million (10.8%) and \$30.4 million (13.7%), respectively.
- The 27 countries of the **European Union** (EU) purchased \$3.85 billion in Wisconsin exports, or 18.7% of the state's total, through September 2025 vs. the same period in 2024. Wisconsin's exports to the EU (treated as a single market) were less than what was shipped to Canada, but more than what was shipped to Mexico. The EU was also the source of \$7.0 billion, or 24.9%, of the total value of goods imported into the state.
 - With the fifth-largest economy in the EU, the **Netherlands** is also a major logistical hub for shipments bound for many parts of Europe. Total exports grew by \$312.8 million, or 53.7%, lifting this country's ranking to No. 3 overall through September. Industrial machinery, constituting 69% of total exports to this market, increased by \$303 million, or 96.7%, while shipments of electrical machinery and medical and scientific instruments decreased by \$6.7 million (9.7%) and \$2.6 million (8%), respectively.
 - Exports to **Germany** decreased by \$188.9 million (20.6%) through September 2025, primarily due to a \$180.5 million (84.5%) decline in shipments of aircraft, spacecraft, and parts, resulting in a drop in rank to No. 2 for the EU and No. 5 overall. Industrial machinery exports, comprising 22.0% of total exports to this market, increased by \$21.9 million, or 16.3%, through September.
 - Although **Belgium** has a relatively small economy, the port of Antwerp is the second-largest port in the EU, servicing many European markets. Exports through September 2025 decreased modestly, down \$45.1 million, or 6.83%, vs. the same period in 2024. Decreases in shipments of vehicles and parts (down \$153 million, or 64.9%) and electrical machinery (down \$6.3 million, or 40.1%) were offset by increases in shipments of industrial machinery (up \$125 million, or 40.8%), articles of iron or steel (up \$17.3 million, or 1,038.90%), and organic chemicals (up \$8.6 million, or 1,185.3%).
- **Mexico** remained the second-largest export destination country, purchasing \$3,112,816,135 even after exports to this market decreased by \$205.7 million, or 6.2%, through September 2025 vs. the year prior.
 - The greatest declines in exports occurred in shipments of electrical machinery (down \$116.1 million, or 16%), industrial machinery (down \$57.8 million, or 7.1%), and articles of iron or steel (down \$33.3 million, or 22.4%). Exports of plastic products, medical and scientific instruments, and cereals increased by \$34.9 million (11.1%), \$26.7 million (14.4%), and \$64.1 million (201.5%), respectively.
 - Mexico continued as Wisconsin's 3rd top source for imported goods despite decreasing by \$807.7 million (17.6%) from this time last year. Vehicles and parts along with medical and scientific instruments were lower by the greatest amounts, down \$436.3 million (27.9%) and \$221.5 million (55%), respectively.
- Through September, **China** was the destination for \$766.9 million worth of Wisconsin exports (down \$426.6 million, or 35.7%) and the third-largest source of imports at \$4.234 billion (down \$545.7 million, or 11.42%).
 - The largest declines in exports to China occurred in electrical machinery and industrial machinery, down \$168.5 million (74.7%) and \$48.6 million (23.8%), respectively. Increases occurred in meat (up \$10 million, or 463.3%) and miscellaneous edible preparations (up \$12 million, or 166.4%).
 - Four of the top 10 product categories imported from China recorded growth, including special classification provisions (up \$79.3 million, or 69.7%) and pharmaceuticals (up \$86.8 million, or 93.1%). Decreases occurred in imports of furniture, bedding, and lamps (down \$71.1 million, or 26.5%) industrial machinery (down \$142.6 million, or 11%), and electrical machinery (down \$133.6 million, or 13.7%).
- Exports to the **United Kingdom**, Wisconsin's sixth-largest export destination, increased by \$84.2 million, or 14.3%, during the first three quarters of 2025. Much of this increase was due to growth in shipments of aircraft, spacecraft, and parts (up \$73.9 million, or 76.2%) and industrial machinery (up \$19.9 million, or 12%). Of the top 10 product categories exported to this market, only medical and scientific instruments and electrical machinery recorded declines in the amounts of \$4.1 million (7.3%) and \$13.4 million (22%), respectively.

PRODUCT SUMMARY

- **Industrial machinery** is a very broad product category that includes metal forming and fabricating machinery, heating and cooling equipment, construction equipment, computers, food processing equipment, packaging machinery, and parts. In 2024, exports of industrial machinery reached a new record of \$7.8 billion. Through September 2025, exports of this product category further increased by \$625.1 million, or 10.6%, vs. 2024.
 - Automatic data processing machines, the top subcategory comprising \$1.96 billion, or 30.1%, of total exports within the industrial machinery category, recorded impressive growth in the amount of \$919.8 million (88.38%). The Netherlands, Singapore, Taiwan, and Belgium received 64.3% of this value.
 - Exports of transmission shafts, bearings, gears, etc., totaled \$410.8 million, a decrease of \$29.4 million, or 6.7%, vs. 2024. Canada received 22.3% of this value, or \$91.7 million, (a decrease of 19%), followed by Mexico with \$62.9 million (an increase of 1.8%).
 - Spark-ignition internal combustion engines, the third-leading subcategory through September, totaled \$375.2 million, representing an increase of \$15.1 million, or 4.2%, vs. the same period in 2024. Belgium received \$164.5 million, or 43.9%, of the total (up 16.9%), followed by Canada with \$50.4 million (up just 0.1%), and Brazil with \$44.7 million (down 8.3%).
 - Imports of industrial machinery into Wisconsin totaled \$6.4 billion through September (up \$224.4 million, or 3.6%, vs. the year prior). China and Vietnam were the top two sources of this subcategory, supplying \$1.15 billion (17.9%) and \$1.04 billion (16.3%), respectively.
- Wisconsin exports of **agricultural and food products** appear in multiple categories. Added together into a single supercategory, the total value of goods exported amounted to \$2.97 billion through September 2025, a decrease of \$75.6 million, or 2.5%, vs. the same time frame the year prior.
 - Miscellaneous edible preparations maintained the top agricultural subcategory at \$407.8 million (up \$39 million, or 10.6%), followed by dairy products, eggs, and honey at \$339.3 million (up \$26.8 million, or 8.6%), and prepared vegetables, fruits, and nuts at \$270.2 million (down \$8.4 million, or 3%).
 - A full 34.7% of Wisconsin's agricultural exports were shipped to Canada through September of this year, although this was a decrease of \$76.7 million, or 6.9%, from 2024. Mexico's purchases of this supercategory increased by \$38.6 million, or 11.9%, while China's declined \$65.6 million, or 27.33%.

- Exports of **electrical machinery** totaled \$2.1 billion through September 2025, a decline of \$335.4 million, or 13.7%. Exports of this product category set an all-time high in 2024 in the amount of \$3.1 billion.
 - Electrical transmission, static conversion, and adaptive power supplies, the top subcategory, saw exports of \$325.4 million through September 2025, a decrease of \$54.8 million, or 14.4%. Exports of insulated wire/cable totaled \$215 million (up \$13.2 million, or 6.5%) while electrical generating sets declined by \$17.1 million, or 7.7%, resulting in \$204.8 million in exports through September 2025 vs. 2024.
 - Canada and Mexico together purchased \$1.2 billion, or 56.8%, of this product category while exports to China, previously the third-largest export market, decreased significantly, down \$168.5 million, or 74.7%.
- Wisconsin's exports of **medical and scientific instruments** totaled \$1.64 billion through September 2025, representing a decrease of \$40.3 million, or 2.4%, vs. the same period the year prior.
 - Medical, surgical, dental, and veterinary instruments, the top subcategory, increased by \$51.2 million or 10.7%, while X-ray apparatuses, the No. 2 subcategory, declined by \$54.2 million (13.1%). The No. 3 subcategory, instruments for physical or chemical analysis, also decreased by \$24.6 million (14.5%).
 - Growth in exports of this product category to Mexico in the amount of \$26.7 million, or 14.4%, allowed this market to surpass China, which decreased purchases in the amount of \$78.4 million, or 12.5%. Exports to Canada, moving down to No. 4 from No. 3, declined by \$23.4 million, or 14.6%.
- Exports of **plastic products** decreased by \$52 million, or 4.2%, through September 2025. A decline in exports of plates, sheets, and film in the amount of \$34.5 million (9.2%) was partially offset by increases in shipments of self-adhesive plates, sheets, and film, up \$16.4 million (19.3%), and amino resins, up \$12.7 million (36%). Canada and Mexico together accounted for \$782.3 million, or 65.2%, of the export volume.
- **Vehicles and parts** exports declined by 7.6% in 2024 and continued their downward trend in 2025 (down \$393.2 million, or 27.4%, through September), dropping this category to the No. 5 position. The top three subcategories were parts and accessories for vehicles (down \$31.1 million, or 8.5%), special purpose vehicles (up \$7.5 million, or 3.5%), and tractors (down \$213.8 million, or 60.3%). Canada purchased 36.8% of this category despite a decline of \$153.5 million (28.6%) since this time in 2024.
